Charter of Patients' Rights and Responsibilities

Patient Rights:

- i) Right to information about the nature of illness, proposed investigations and possible complications.
- ii) Right to information on the rates charged for each type of service/facilities provided.
- iii) Access to copy of case papers, patient records, investigation reports and detailed bills.
- iv) Right to informed consent prior to specific tests/treatment.
- v) Right to seek second opinion from appropriate clinician.
- vi) Right to human dignity and privacy during treatment.
- vii) Right to ensure presence of female attendant during examination of female patient.
- viii) Right to non-discrimination of any form on the basis of HIV status.
- ix) Right to choose alternative treatment if options are available.
- x) Right to non denial of release of dead body of patient.
- xi) Right of the patient against any form of exploitation.
- xii) Right to consent of the patient before digitisation of medical records.
- xiii) Right to care according to prescribed rates wherever relevant.
- xiv) Right to choose source of obtaining medicines or tests.
- xv) Right to protection and compensation for patients involved in clinical trials.
- xvi) Right to protection and compensation for patients involved in Biomedical and health researches.
- xvii) Right to patient education.
- xviii) Right to be heard and seek redressal.
- xix) Right to proper referral and transfer.

Patient Responsibilities:

- i) Provide all health related information.
- ii) Cooperate with Doctors during examination, treatment.
- iii) Follow all instructions.
- iv) Pay hospital agreed fees on time
- v) Respect dignity of doctors and other hospital staff
- vi) Never resort to violence.
- vii) Fulfilment of payment of all bills for treatment received in case of abrupt discharge from hospitals
