**1. Inziaklut theite:**

Sawrkar hnathawk, Sawrkar-a MR bill thei emaw Sawrkar hnathawkin a chenpui Sawrkar-a MR a bill sak theithe chu Mizoram Health Care Scheme hnuai hian inziahlun phal a ni lova, **Sawrkar-a MR bill theilo zawng zawngte chu he Scheme hnuai hian an inziaklut thei ang.**

Sawrkar hnathawk March Ni 31, 2025 hmaa pension tur te tan a inziahlun theih thung ang.

**2. Hamthatna dawn theih zat:**
