Chuvangin, Restricted Licence pek thin hi mipui hriselna venhim a nih theih nan Mizoramah a thar pek tawh loh tum a ni.

Dan chuan pharmacist ngeiin damdawi a enkawl hi a phut tlat a, heng dan – *Section.42 of the Pharmacy Act, 1948, Regulation 3.4(a) leh Regulation 9.1(a) of Pharmacy Practice Regulation, 2015 bakah Rule 65(2) of the Drugs Rules, 1945* te hian chiang takin an tarlang a ni. Chutichuan, danin mipui himna a dah pawimawhzia hrerengin hetiang hian Restricted Licence hi kalpui a ni tawh dawn a, hman zui nghal tur a ni ang :-

1. Danah Restricted Licence hian *prescription drugs* a huam lo va, doctor prescription dawngsawng thei a nih bawk loh avangin dawrah *prescription drugs* kawl phal a ni lo. Hei hian Restricted Licence awmzia a tarlang chiang hle a ni. Chuvangin, district headquarter chinah chuan pharmacist-te enkawl pharmacy engemaw zat a awm vek tawh hlawm avangin Restricted Licence pek a ni tawh lo vang.
2. District headquarter-a Restricted Licence awm tawhsate chu a neituin dawr a siam theih chhung siam nan a hmang ang a, a theih loh chinah midang hminga thlak theih a ni lo vang.
3. Restricted Licence neituin damdawi dawr siam zui a duh chuan danin a phut angin Regd.Pharmacist ruaiin General Retail Licence a dil thei ang.
4. Restricted Licence pekchhuah hi State Licensing Authority thuneihna a nih angin, thingtlang pilril zawk dinhmun thlirin a tul angin hma a la thei ang.


