3. Damlovin prescription a nei tur a ni a, chumi mil chuan damdawi pek tur a ni
4. Prescription chu damdawi dawr neitu e-mail ID-ah thawn theih a ni bawk. E-mail hmanga tih a nih chuan damdawi zuartu e-mail ID chu Licensing Authority hnenah hriattir tur a ni.
5. Natna benvawn neite prescription chu doctor-in a pekchhuah atanga ni 30 chhung hman theih a ni a. Natna satliah prescription chu pekchhuah atanga ni 7 chhung pawm sak tur a ni ang.
6. Cash memo pek ngei tur a ni a, e-mail kaltlanga hralh chu e-mail-a thawn kir tur a ni.
7. Doorstep delivery hi district khat huamchhung atan chauh phal a ni.
8. Endik theihin damdawi order-na leh pekchhuahna damdawi dawrin a vawng tur a ni.
