Sealed Tenders are hereby invited as per the schedule annexed to this notice on behalf of the Chairman, State Health Society, Mizoram from reputed and bonafide Manufacturers or their only authorized dealers, for **Supply of Equipments under**State Blood Cell (SBC) which will be received by the Mission Director, NHM, H&FW Department, Dinthar, Aizawl, Mizoram on behalf of State Blood Cell (SBC) on or before 13th February, 2017 up to 12:00 Noon. Tenders are to be opened by Mission Director, NHM, Mizoram, Aizawl or his authorized representatives at 1:00 PM on the same day. The Tenderers or their representatives may also be present at the time of opening of the Quotations, if they so desire.

TERMS & CONDITIONS

- 1. Tenders submitted by Authorized dealers should attach Authorization or Distributorship or Dealership as the case may be certificates from the concerned Manufacturers. A Gazette Officer or Notary, however, should duly attest Photostat copies. Original Certificate should be produced at the time of opening, if demanded.
- 2. Earnest Money should accompany tenders. 3% of bid amount in case of Non-Tribal and 2% of bid amount in case of Tribal Tenders in the form of Deposit at Call/ Bank Guarantee/ Fixed Deposit in original, from any Nationalized Bank of India or Postal Saving Certificate duly pledged in favor of Mission Director, State Health Mission, Mizoram, Aizawl.
- 3. Tenders should be submitted in duplicate marked "Original" and "Duplicate" on the cover envelope. The cover of the tenders should be super scribed as "Tender for Equipments under State Blood Cell" addressed to Mission Director, State Health Mission, Mizoram, Aizawl and should clearly clearly indicate full postal address of the tenderer.
- 4. **a)** Tenders must be submitted in the prescribed form only. Quoted rates in terms of Indian Rupees will be considered inclusive of all taxes and duties. If there are different brands, the separate rates for such brands with specific details shall also be mentioned.
 - **b**) All pages of the tender papers shall be printed, signed, stamped and dated; hand written quotation shall not be entertained. Any page or pages not signed, stamped and dated will be rejected at the time of opening of tender. Correction, if any, shall be initialed, stamped and dated.

- 5. Tender must be accompanied by the following documents
 - **a)** Up to date *original* MVAT Clearance Certificate *in form 38* issued by Taxation Department, Govt. of Mizoram.
 - **b)** Photo copy of MVAT Registration Certificate duly attested by a Gazetted Officer or Notary. Original Certificates shall be produced at the time of opening of the tenders/quotations, if demanded.
 - **c**) Photo copy of Scheduled Tribe Certificate duly attested by a Gazetted Officer or Notary. Original Certificates shall be produced at the time of opening of the tenders/ quotations, if demanded.
 - d) Non-tribal tenderers shall affix a Non-Judicial Adhesive Stamp worth at least Rs.7.50.
- 6. Firms submitting their tenders should attach Photo copy of their Certificate of Permission/License duly attested by a Gazette Officer or Notary. Original Certificate should be produced at the time of opening, if demanded.
- 7. The tender shall submit Photo copy of ISI certificate/ISO 13485/14001/9001 attested by Gazetted Officer.
- 8. If any tenderer violates or fails to fulfill any one of the clauses, his or her tender should be rejected at the time of opening the tender.
- 9. Tenderer should quote their rates in terms of Indian Rupees and should be quoted inclusive of all taxes and duties.
- 10. Tenderer should quote their rates F.O.R.
- 11. Rate should be quoted in terms Indian Rupees and inclusive of all taxes and duties.
- 12. Once the rate is accepted and communicated to the successful firm, the same will remain valid during the validity period of the agreement with the approved supplier and no price escalation will be permissible during the validity period, which is normally for a period of 12 months and is extendable, if mutually agreed upon by both the parties i.e. State Health Mission, H&FW Department, Govt. of Mizoram and concerned approved supplier, subject to recommendation to the Purchase Committee, Mizoram State Health Society, as the case may be.
- 13. A successful firm will have to supply the materials within the period fixed by the Department/Authority. If the supply cannot be made within the stipulated period without any intimation, the Department has the right to procure the materials from any other sources and the differences in prices, if any, will be realized from the Security Deposit of the approved supplier, as mentioned herein, without assigning any reason thereof.
- 14. A successful firm should furnish Security Deposit of 5% of the value of the supply before issue of supply order in the form of Demand Draft/Fixed Deposit in any Nationalized Bank

- of India or Postal Saving Certificate, as the case may be, duly pledged in favor of Mission Director, State Health Mission, Mizoram, Aizawl.
- 15. A successful firm should execute an appropriate Deeds of Agreement within 30 days from the date of issue of acceptance of their quoted rates failing which their quoted rate will be treated as invalid.
- 16. The undersigned shall not be bound to accept the lowest rate or any of the tenders and reserves the right to accept or reject any tenders without assigning any reason thereof.
- 17. Late/delayed tenders will not be entertained. Certificates other than those stated in the above clauses should not be attached. Any other/further clarifications in connection with submission of the tender may be made from the office of Mission Director, State Health Mission, Mizoram, Aizawl during office hours on all working days.
- 18. In case of any legal disputes/litigations arising out of this Tender Notice or its terms, the Courts of Law at Aizawl only shall have jurisdiction to adjudicate the same.
- 19. Payments will be made only after the materials are received in full and in good condition by Vigilance Committee.
- 20. Firms or individual who attempts for negotiation/campaign, direct or indirect, on the part of tender with the authority to whom he has submitted the Tender or the authority who is competent finally to accept, shall be excluded from consideration, if proved.
