TENDER NOTICE

Sealed Tenders in duplicates are hereby invited on behalf of the Governor of Mizoram from reputed and bonafide firms/ distributors/ agents and Manufacturers or their authorized dealer for the supply, delivery, installation and commissioning on "Turn Key Basis" of Incinerator at District Hospital, Serchhip, Mamit, Lawngtlai and Champhai during 2016-2017, which will be received by the Director, Hospital & Medical Education, Mizoram, Aizawl on or before 19th December, 2016 upto 1:00 PM under the terms and conditions laid down below. Quotations are to be opened by Director, Hospital & Medical Education, Mizoram, Aizawl or his authorized representatives at 1:30 PM on the same day. The Tenderers or their representative may also be present at the time of opening of the Quotations, if they so desire.

TERMS & CONDITIONS

- 1. Tenders received from firms and individuals who are not bonafide firms / Distributors / agents and Manufacturers or their authorized dealers but only authorized to quote on behalf of their principals/distributors/agents shall not be accepted.
- 2. Tenders should be submitted in the prescribed form only, to be obtained from the office of the Director, Hospital & Medical Education.
- 3. Each tender should be accompanied by Earnest Money deposit of 2% of the quoted total values upto the maximum of Rs.2.00 lakhs (Rupees two lakhs)only, in case of Non-Tribal, 1% of the quoted value upto the maximum of Rs. 1.00 lakh (One lakh) only, in the case of Tribal Tenderers in the form of Deposit at Call/ Fixed Deposit in original, from any Nationalized Bank of India or Postal Saving Certificate duly pledged in favour of Director, Hospital & Medical Education, Mizoram, Aizawl and be submitted with the "Technical Bid".
- 4. (a) Tenders should be submitted in duplicate marked "Original" and "Duplicate" on the cover envelope and in two parts each. The first part shall comprise of the "TECHNICAL BID" and the second part, the "PRICE BID". Both the Technical and the Price Bid shall be duly sealed and superscribed notifying the nature of such bid, and shall be submitted in separate orders.

(b) The bids shall also be superscribed as "Tender for Supply, Delivery, Installation and Commissioning of of Incinerator at District Hospital, Serchhip, Mamit, Lawngtlai and Champhai" duly addressed to the Director, Hospital & Medical Education, Government of Mizoram, Aizawl.

5. The "**Technical Bid**" and the "**Price Bid**" contained in two separate covers shall be put together in a single cover duly sealed with the Tender No. and the date of opening subscribed on all covers. Each such bid should be computer printed and signed, stamp and dated by the authorized signatory clearly indicating the name of the signatory and should be affixed with official seal of the tenderer. In case any page is found unsigned, the relevant tender should be liable to be rejected. Corrections, if any, should be initialed, dated and stamped with the official seal of the tenderer/bidder.

- 6 Performance Statements/Certificates from previous installations must be enclosed with the **"Technical Bid.**" Technical Specification can be seen in the Annexure.
- 7 All tenderers/bidders should quote their rates for the supply, delivery, installation, commissioning including civil works and the electrical work and the modifications/restructuring of the proposed room on turnkey basis at site i.e District Hospital, Champhai, Lawngtlai, Mamit and Kolasib inclusive of all taxes, duties and charges.
- 8 No tenderers/bidders shall be provided with any Civil/Structural layout/drawings/plans of the existing Civil Hospital, Aizawl. All tenderers/ bidders must submit a schematic drawing for the Incinerator along with the "**Technical Bid**".
- 9. Warranty period should be clearly mentioned.
- 10.Non-tribal tenderer should affix a Non- Judicial Court Fee Stamp worth at least Rs.7.50/and should furnish Photostat copy of valid VAT/Sales Tax Clearance Certificate up to the latest year for which assessment has been made by the concerned authority and duly attested by a Gazette Officer or Notary. Original Certificate should be produced at the time of opening, if demanded.
- 11. Tribal tenderer should furnish original copy of Tribal Certificate issued by the competent authority and Photostat copy of valid VAT/Profession Tax Clearance Certificate up to the latest year for which assessment has been made by the concerned authority duly attested by a Gazette Officer or Notary. Original Certificates should be produced at the time of opening, if demanded.
- 12. Manufacturers submitting their tenders should attach Photostat copy of their Manufacturing License duly attested by a Gazette Officer or Notary. Original Certificate should be produced at the time of opening, if demanded.
- 13. Tenderer should enclose detailed specifications of the equipments including software incorporated, if any, and also indicate any other optional items, facilities for up gradation, post-sale/installation service, warranty etc. and also enclose relevant catalogues/literature of the quoted product.
- 14. If any tenderer violates or fails to fulfill any one of the clauses, his or her tender is liable to be rejected at the time of opening the tender.
- 15.Tenderer should quote their rates in terms of Indian Rupees, FOR destination inclusive of supply, installation and commissioning with all taxes including *Mizoram Value Added Tax (MVAT)* @ 5% / *Mizoram Entry Tax (MET)* @ 2%. Any charges, if any, should be clearly indicated with the amount.
- 16. A successful tenderer/bidder will have to supply, deliver, install and commission the entire system at the Hospital within 12 (twelve) months from the date of allotment of work-order.
- 17. Once the rate is accepted and communicated to the successful firm, the same will remain valid during the validity period of the agreement with the approved supplier and no price escalation will be permissible during the validity period, which is normally for a period of 12 months and is extendable, if mutually agreed upon by both the parties i.e. the Health & Family Welfare Department and concerned approved supplier, subject to recommendation to the State Purchase Advisory Board or the Departmental Purchase Advisory Board, as the case may be.

- 18. A successful tenderer/bidder will have to execute a Deed of Agreement with the Government of Mizoram represented by its authorized officer within 30 days from the date of issue of the letter of acceptance of their offer or of allotment of the work from the concerned authority, as the case may be.
- 19. A successful tenderer/bidder shall have to furnish a performance security equivalent to 5% of the award amount form of deposit at call/fixed deposit/bank draft in original from any Nationalized Bank of India or Postal Savings Certificate, duly pledged in favor of Director, Hospital and Medical Education, Government of Mizoram.
- 20. A "**Technical Bid**" shall contain all relevant documents as mentioned in the terms and conditions, including the specifications of the proposed project. A "**Price Bid**" should contain the price of the proposed project and the cost of AMC with detail terms and conditions on the turnkey basis and also contain the commercial terms and conditions of the bidders, if any.
- 21. Tenderers/bidders should also furnish the details about the proposed system of training to be imparted free of cost to the technicians of the Civil Hospital, Aizawl.
- 22. The undersigned shall not be bound to accept the lowest rate or any of the tenders and reserves the right to accept or reject any tenders without assigning any reason thereof.
- 23. In case of any legal disputes/litigations arising out of this Tender Notice or its terms, the Courts of Law at Aizawl only shall have jurisdiction to adjudicate the same.
- 24. All payments will be made only after the materials are received and completion of installation and commission, subject to the contents of the Deed of Agreement executed between the parties.
- 25. Any attempts for negotiation/campaign, direct or indirect, on the part of a tender with the authority to whom he has submitted the Tender or the authority who is competent finally to accept, shall render such Tender liable to be excluded from consideration, if proved.
- 26. Late/delayed tenders will not be entertained.
