Chutianga tih ÷ulna leh remchang nei vêng leh khuua Local Level Task Force/ Village Level Task Force te'n anmahni bialtu Chief Medical Officer hnenah report zel tur a ni a. Chief Medical Officer chuan a ÷ul angin a lo bawhzui nghal zel ang.

2. Health & Family Welfare Department-in khawtual mite nena țanghova a din Kiosk ah chuan veng/ khaw dang ațanga test mamawhrawn pantute pawh hnar lovin an test ve zel tur a ni.

3. Covid test ti turte'n an hriselna dinhmun sawi chiangin mahni veng LLTF/ VLTF te hriattir hmasak zel tur a ni a. Symptom nei lo nia hriatte chuan Kiosk hi an remchan danin an pan mai thei ang.
